Seeing only 30 attendees, the conference was organised by a group of students who wanted to go beyond the classroom by sharing stories and presenting research. BOOKING AND PAYMENT

Once a booking form has been returned you are required to pay a 25% non-refundable deposit.

Payment for your sponsorship is due 14 days from receiving your invoice or before the 28th of December, 2025, whichever is soonest.

By completing a booking form, you are legally liable for the terms and conditions outlined below.

Payment can be made by:

- BACS: BACS details will be provided on your invoice.
- Cheque: Cheques should be made payable to Abertay University Students' Association, clearly stating your invoice number on the reverse.

The Abertay Ethical Hacking Society, under the umbrella of Abertay Students' Association, reserve the right to refuse any booking which they deem unsuitable for inclusion in the event and holds the sole right to determine such matters.

Agencies booking sponsorships on behalf of a client are responsible for passing on all relevant information, including these Terms & Conditions, to the appropriate person and Abertay Students' Association will not be held responsible for the failure of an agency to supply the correct details.

Late payment may lead to the sponsorship opportunity being withdrawn by Abertay Students' Association and offered to other public and/or commercial organisations.

By agreeing to sponsor Securi-Tay 2025, you agree that the sponsorship is non-refundable, unless the conference is indefinitely cancelled.

Finally, for a booking to be successful, proof of third-party liability insurance for the business' costs associated with the conference must be supplied. If insurance details are not supplied within the payment timeframe then Abertay Students' Association reserves the right to withdraw the booking.

Please supply the proof with the booking form.

COMPANY AND SPONSOR STANDS

Company stands should be staffed by delegates attending as part of the sponsors' ticket allowance, additional delegates will be required to purchase their own tickets.

Any stands that are larger than the designated space agreed on the booking form will be refused. If you require additional space, you must obtain permission from the Securi-Tay 2025 Committee prior to the event.

Every stall will be provided with one table and a number of chairs, dependant on the selected sponsorship package; measurements are available upon request. If you do not require these facilities, please notify the Securi-Tay 2025 Committee on:

If you're bringing your own stall structure, you are responsible for setting up and taking down the stall.

Details of the size of the structure must be provided in advance as to be kept in line with other sponsors. Setting up time is at 8am on the day of the conference although sponsors are welcome to contact us if they wish to set up the day before. Taking down time is 7pm on the day of the conference. Please let us know if you will be bringing your own equipment ahead of time. If you are having equipment delivered by a third-party courier, please let us know so that we can ensure they are delivered to us safely. Any equipment left for collection by a third-party courier after the event has finished is done so at the owner's risk. Abertay Students' Association will not take any responsibility for loss, damage or theft of any items.

Distribution and Storage of Materials

Distribution of promotional material is only allowed at designated company stands or sponsor stands as per the package description. At no time may you distribute items, flyers or other material in any other part of the conference or Abertay University buildings.

Materials handed out at the event must relate specifically to your organisation. Sharing of stalls or distributing materials not directly related to your organisation is not permitted and could result in immediate expulsion.

All materials utilised at your stand (including boxes, papers and giveaways) must be cleared from the event no later than 5pm on the 5th of March 2025. Any items left after this time are not the responsibility of Abertay Students' Association and may be discarded during the clean-up. Items may only be stored underneath your allocated stand or space. At no time may you utilise the area surrounding your stand for storage.

CANCELLATIONS AND POSTPONING

In the event that Securi-Tay 2025 is postponed, the conference will be rescheduled for a later date and sponsors and attendees will be informed of the change no later than 4 calendar weeks before the proposed date of the conference. Sponsorships that have already been paid will not be eligible for a refund.

In the event that Securi-Tay 2025 is cancelled and cannot be rearranged for a later date, all sponsors and attendees will be informed of the change. Sponsorships that have already been paid will not² be eligible for a full refund, though in certain cases partial refunds may be offered as an alternative.

RESTRICTIONS ON DISTRIBUTION

The taking of any form of payment (including but not limited to: debit/credit card, cash or cheque) is forbidden at all stalls, unless specific arrangements have been made beforehand with Abertay Students' Association.

Failure to comply will result in immediate expulsion.

Stalls must not display images that may be deemed offensive or demeaning to liberation groups at the event. In addition, Abertay Students' Association retains the right to veto the display or sale of any goods it reasonably deems offensive and holds the sole right to determine such matters.

GENERAL DATA PROTECTION REGULATION (GDPR)

By completing and submitting any document relating to the sponsorship of Securi-Tay 2025, you are agreeing to the collection and processing of your personal data by the Securi-Tay 2025 Committee and Abertay Students' Association in accordance with EU GDPR regulations.

Further, by completing and submitting any document relating to the sponsorship of Securi-Tay 2025, you are agreeing to the Abertay Ethical Hacking Society and related social media accounts using your company name and logo in advertising and promotional material.

² For transparency under charity regulations: the deposit that Securi-Tay 2025 take from sponsorships is used to secure branding and catering for the conference in advance of final numbers. In the event of rescheduling this would not have a financial impact, however if the conference needed to be cancelled there would be a financial impact to the organisers, this is why sponsors will not be eligible for a full refund.

COVID-19

With all COVID rules and restrictions currently lifted in Scotland, our team is confident that Securi-Tay 2025 will be in person. The health and safety of our attendees is of utmost importance and all decisions regarding the conference will be made in adherence to guidance and recommendations issued by the Scottish government at the time of the event.

EXPULSION

Failure to meet the terms and conditions may result in immediate expulsion from the event without a refund for your booking.
